### PURPOSE AND LEGAL BASIS OF PROCESSING PERSONAL DATA

#### What personal data do we collect?

When you visit this website, certain technical data is processed automatically, including:

- IP address
- Date and time of access
- Name of the retrieved file
- Browser type and version
- Referrer URL
- Operating system

#### For what purposes do we process your personal data?

This data is processed for the purposes of providing the website and ensuring its stability and security.

**We will not process your personal data for any other purposes, other than the ones already described.**

#### What is the legal basis for processing?

The legal basis for processing your data is Art. 6(1)(f) GDPR (legitimate interest).

## RECIPIENTS OF YOUR DATA

We may use IT service providers (e.g. hosting providers) acting on our behalf under Art. 28 GDPR.

These providers process personal data only on our instructions.

## THIRD COUNTRY TRANSFER

Your data is processed within EU/EEA when you visit the website. If personal data is transferred outside the EEA, appropriate safeguards such as Standard Contractual Clauses are applied.

## STORAGE PERIOD

Server log data is stored only for a limited period and deleted thereafter unless required for security or legal purposes.

## RIGHTS OF DATA SUBJECTS

Subject to the legal requirements, you have the right to contact our Data Protection Officer at any time and free of charge with an informal message to the email address: [privacy@vantagetowers.com](mailto:privacy@vantagetowers.com) in order to exercise your rights under the GDPR. You have the right:

- in accordance with Art. 15 GDPR, to request information about your personal data processed by us.
- in accordance with Art. 16 GDPR, to request the immediate correction of incorrect or incomplete personal data stored by us.
- in accordance with Art. 17 GDPR, to request the deletion of your personal data stored by us, unless the processing is necessary in particular to fulfil a legal obligation or to assert, exercise or defend legal claims.
- in accordance with Art. 18 GDPR, to demand the restriction of the processing of your personal data if you dispute the accuracy of the data, if the processing is unlawful and you refuse to delete it, if we no longer need the personal data but you need it to assert legal claims.
- in accordance with Art. 20 GDPR, to receive the personal data concerning you, which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller.

**Right of revocation (Art. 7 (3) GDPR):** If we process your personal data on the basis of consent given by you (Art. 6 (1) sentence 1 lit. a) GDPR), you may revoke this consent at any time for the future.
